To provide competitive scholarships for eligible individuals and to sponsor and/or donate to projects intended to enrich the cultural, intellectual, emotional, or physical interests of the residents of Bentley Village or that advance the interests of the Foundation in the greater Bentley Village community and southwest Florida.

Scholarships: In collaboration with the Collier Community Foundation (CCF - See Sched I) and using funds raised by the Foundation, in 2022, seven applicants (two employees and five dependents) were evaluated by four representatives of Bentley Village Foundation (BVF) and the five representatives of CCF. All applicants were all employees or dependents of employees of Classic Bentley Village, Inc., a Florida not-for-profit corporation and Naples area continuing care retirement community now doing business as VI at Bentley Village. The evaluators selected one employee and all five dependents for a total of six renewable scholarships at \$6000/each. These scholars were the maximum allowable under IRS guidelines. Since 2016, BVF has awarded over 92 "Bentley Wings" Competitive Scholarships allowing students to pursue their career educational goals. All scholarship funds are disbursed from a foundation designated account under the investment umbrella of CCF directly to the learning institutions per a written agreement between CCF and the BVF. Awardees were selected via applications scored on a matrix developed cooperatively between the two organizations. Awardees may receive annual renewals until their original courses of study are completed with up to six annual renewals. Serving participants since 2019, our Bentley Wings Competitive Scholarship Program is the largest program administered by CCF. Many awardees have graduated. Our program is also only one to guarantee its students annual renewal availability. This years additions to our total awardee pool brought our total commitments for all existing scholars to \$900,982.

4b (Code:) (Expenses \$ 79,180 including grants of \$ 20,000) (Revenue \$)

Programs and Services: Priorities for 2022 included dealing with emerging needs and offering our target population opportunities for stimulation, education, support and activities to assist them to be safe, healthy, and engaged and to make use services, support systems, community resources, and programs that prevent or minimize decline and disease of an aging population. We enhanced the use of cultural arts with emphasis on expanded use of music and other arts, both therapeutically and to enhance the cultural, recreational, and aesthetic lives of participants, by offering additional programs that featured live music, education, and opportunities to dance. Over 10 such programs were offered in 2022. Our Memory and Music, Music Therapy, and Mindfulness programs proved efficacious in improving quality of life by offering preventive, rehabilitative, or palliative care to the portion of our service population who are at-risk to develop or who already suffer from disabling brain diseases like dementia, Alzheimers, and other advanced cognitive disorders. We partnered with the House of Music Therapy, FGCU Bower School of Music, Baker Senior Center Naples, and individual musicians to create, fund, and offer programs, the combined intervention of which proved to help participants maintain or restore their health, and helped them to recall memories and to fight depression and cognitive decline. (Criteria for selection of programs were based on accepted studies that demonstrate that music is widely distributed throughout the brain, but locally specialized.) These services included: Informal participative events like sing-alongs, name that tune, name the composer, as well as live listener-friendly music performances in both independent and residential settings at a rate of at least three performances per month. Services were expanded to Baker Senior Center Naples in the final quarter of year and were warmly received in their Music Makes Memories (3M), their Dementia Respite Music Therapy Program. Belles and Beaus and the Bentley Musicians Group in 2022 formally moved under the funding umbrella of our participative music program. Jodie DeSalvo, a professional pianist and conductor, is conducting the singers. The musicians practice separately. This allows over 40 resident musicians an opportunity to practice regularly and perform for other seniors, benefiting both. Formal music therapy programs, under professional supervision provided by the House of Music therapy, were restarted in ALR and Skilled nursing venues after a nearly three-year closure due to COVID. By year end 2022, nine such sessions were offered monthly. Music therapy encompasses some activities and techniques used in Memory and Music but they are monitored and tailored specifically for the participants issues. Weekly sessions are held for Memory Unit residents, who are often in the later stages of dementia. These them help with memory recall, reduce agitation, facilitate communication, improve sleep, and improve physical coordination. Mindfulness group sessions were offered in late summer and early autumn to assist participants to recover from the effects of nearly three years of COVID isolation. Over 40 individuals participated. Angela Tarquini- Sanders of Mindful Mindz began collaborating with the Foundation to develop programs in 2023 to acquire and utilize Mindfulness as meditative discipline and to assist them to practice the techniques involved to deal with issues arising from stresses of aging. Future programs will also address bring these skills to the many caregivers experiencing grief and loss, life change, and negative and debilitating situation. These programs are being designed with an eye toward future expansion into other senior venues.

The Foundation partnered with other community organizations to provide additional community services by: Contracting at \$15,000 with FGCU Continuing Education Academy to provide a full year of FGCU Academy lectures, initially streaming and later on site, at Classic Bentley Village Inc, and to residents at all levels of care as well as FGCU Academy-series members. Providing a \$800 to preserve the Residents Councils Forum fund for four user-recommended educational programs annually. Forum is run by volunteers. Providing an award of \$2000 to the Literary Council Gulf Coast to provide materials and supports for offering English as a Second Language programs. Volunteers provide the tutoring. Seniors Helping Seniors: We partnered with the Baker Senior Center Naples dementia respite program via a \$20,000 to award to initiate an expansion of Music Makes Memories (3M), their Dementia Respite Music Therapy Program. Ian Relief: We partnered with the Collier Community Foundations disaster emergency relief efforts, contributing over \$50,000 to assist 500 plus hourly employees of Classic Bentley Village, Inc. Many of those receiving checks had suffered personal loss in addition to loss of income from days of work missed. Awarded \$600 to new citizens under the Citizenship program, which assists Classic Bentley Village, Inc., employees seeking to become to US citizens, assistance with preparation and educational resources.
